


Figure 1: Concession Map for Fifth Licensing Round (May 2022)

1 INTRODUCTION

The Petroleum (Exploration & Production) Act, 2011 requires prequalification of Applicants for Petroleum Rights.

Section 16.2: Prequalification of Applicants for Petroleum Rights.

"Where the Minister is satisfied on the advice of the Directorate, that the Applicant for a petroleum right or to be an operator thereunder has been evaluated and accepted to possess such technical, financial, operational, industrial or other expertise to qualify as a permit holder, license or an operator, he may issue to the Applicant a notice of qualification."

This document outlines the Prequalification requirements and provides a template for Companies to submit their Prequalification Applications.



2 APPLICATION AS OPERATOR OR PETROLEUM RIGHT HOLDER

"Any person, may upon the payment of the application fee, apply to the Minister to qualify as an Applicant for petroleum right or operator".

Submission of the Prequalification Application

Two paper copies of the Prequalification Application should be provided in single sided A4 format and one copy in digital pdf format on DVD/USB.

The Application Fee for Prequalification is US\(\frac{1}{2}\)15,000 (Fifteen Thousand United States Dollars)

Fees may be paid by Banker Cheque (Draft) or by wire bank transfer into the Petroleum Directorate's bank account.

Upon receipt of the cleared funds into the Petroleum Directorate's bank account, the Petroleum Directorate will issue a receipt to confirm that payment has been received.

Following submission of the Prequalification Application, the Petroleum Directorate will evaluate the application. For the Fifth Licensing Round, the Director General of Petroleum Directorate will issue to the Applicant a "Notice of Qualification" to apply.



The Petroleum Directorate will confirm receipt of Applications and intends to complete the evaluation process within 10 working days of receipt and the Director General will then advise companies accordingly.

Please clearly state if you wish to apply for Prequalification for the Fifth Licensing Round as:

- **1.** Operator or,
- 2. Petroleum Rightholder (Partner / Non-Operator)

Note:

- 1. Prequalification as an Operator includes Prequalification as a Petroleum Rightholder.
- 2. Only Operators can submit an Application for the Licensing Round.

Please provide the following details:

- 1. Name of Applicant (XYZ Company as in Certificate of Incorporation).
- **2.** XYZ Company also referred to herein as ("XYZ Company").
- 3. Date of Establishment.
- **4.** Jurisdiction of Incorporation.
- **5.** Give an outline of the corporate structure, including an explanatory diagram, if appropriate, showing Parent, Subsidiary and Affiliate companies.
- **6.** List all companies or individuals which have shares of at least 10% in the Applicant Company.
- 7. List all individuals which have shares of 5% or more in the Applicant Company.
- **8.** Declare if a Private Company or Public Company (Share ticker / Stock Exchange).
- **9.** Address of registered Office (street and postal address, telephone and e-mail).
- **10.** Name of Primary Contact.
- 11. Telephone.
- **12.** E-Mail.
- 13. Website.



4 FINANCIAL PREQUALIFICATION

Please provide the following details:

1. Information on Financial Standing.

- **2.** The value of the total assets of the Applicant Company as of the end of its most recent financial year.
- **3.** A good faith estimates of the total Exploration & Production capital expenditure in activities in each of the last three (3) years.
- **4.** Details of any medium-term plans and/or material contingent liabilities if these could reasonably be expected to materially and adversely impact the financial status of the Applicant.
- **5.** Confirmation that the Applicant has no outstanding financial obligations within Sierra Leone.

Note:

When submitting a bid for Petroleum Rights, the Applicant(s) will have to demonstrate to the Petroleum Directorate their financial capability to undertake its proposed work program.



5 OPERATIONAL / TECHNICAL PREQUALIFICATION

The Applicant (whether seeking Prequalification as an Operator or Petroleum Rightholder) is asked to disclose details of the Applicant's experience with respect to exploration and production activities including:

- **1.** Number of offshore exploration wells drilled or participated in for each of the last three (3) years.
- **2.** Number of offshore wells drilled (as Operator) in each of the last three (3) years with water depths;
 - zero (0) to five hundred (500) metres
 - greater than five hundred (500) meters and up to one thousand (1,000) meters
 - greater than one thousand (1,000) meters
 - greater than two thousand five hundred (2,500) meters

Note:

The Petroleum Directorate is seeking to prequalify Operators who have offshore exploration expertise. Applicants who wish to Prequalify as an Operator in a deep water/ultra-deep-water license would be expected to have the relevant exploration experience. Applicants without the relevant experience should contact the Petroleum Directorate as they will be required to provide further information.

There is no special requirement for prequalification of a Petroleum Rightholder.



6 QHSE POLICY STATEMENT

Applicants should provide a QHSE (Quality, Health, Safety and Environment) Policy Statement.

Note:

When submitting a bid for Petroleum Rights for the Licensing Round, the Applicant(s) will have to provide further information.



7 DATA ROOM VISIT AND TECHNICAL DATA

Applicants wishing to Prequalify as an Operator are required to make a Data Room visit (available in Freetown; Sierra Leone or London; UK) as part of the Prequalification process.

The technical data available to view in the data room includes:

- 1. Technical Presentations
- 2. Technical Reports
- 3. GIS Data Portal
- **4.** 15,780-line km of 2D seismic
- 5. $9,976 \text{ km}^2 \text{ of 3D seismic}$
- **6.** 8 well reports
